why filling out the census forms is important. I learned about Tryon's yearly tea with local authors as a fund raiser, and that Asheville members have established a financial investment group as one of their special interest activities. Jacksonville members have organized a book study on students with disabilities for teachers to fulfill continuing education hours.

I spoke about how our relationship with Brevard College has strengthened this year with our sponsoring a Start Smart workshop in the fall, our two new interns joining us for the second semester, and how 40 young women from the college came to our first meeting and round table discussion. Throughout the conference I heard references to our book sale and how members across the state were appreciative and impressed with the effectiveness of our fundraiser and the scholarships we support.

The workshops I chose to attend on Saturday centered on social media. The first was *Marketing Your Message* and the second was *Moving Your Message Through the Digital World*. I learned that we are right on target concentrating on Facebook and our website.

The History of Ecusta Working Women with Marcy Thompson

APRIL BRANCH PROGRAM



We are delighted to have Marcy Thompson, the Local History Librarian at Transylvania County Library, speak to us about "The History of the Working Women at Ecusta." Her presentation will cover the early years of Ecusta's operation and focus on the roles of women both as employees and in a broader context as part of the Ecusta family. Photographs and *The Echo*, Ecusta's monthly publication, from 1940-1954 will be featured.

Ecusta came into being just after the Great Depression when one sixth of all local workers were on relief. By 1940, Harry (Hans) Straus, a German entrepreneur from New York, employed over 1,300 workers making very good wages and receiving medical care at the Ecusta Paper Mill, raising the area out of the depression. Ecusta was more than just a place of employment; it published *The Echo* to inform workers and to make everyone feel more "like a family." Based on Straus' belief that "productivity increases when people who work together also play together," an array of activities from sport teams to dances, bands and music education were started.

Women played a central role in these activities. As in many industries after Pearl Harbor when men joined the armed forces, women's roles became even more important in the plant and in the "victory gardens" they created.

As Marcy describes herself, "I am from Nebraska. I have a degree in Elementary Education from Chadron State College in western Nebraska and taught in small rural schools for several years. I then came to Appalachian State to get a degree in Library Science while also working in the Buncombe County Library System. After graduation I started working for the Transylvania County Library and spent many years as a Children's and Teen Services Librarian. For the past 12 years I've been the Local History Librarian."

Marcy is the "go-to" local history expert for many authors as well as residents researching local family history. She is in charge of planning library programs regarding local and southeastern regional history and doing collection development for the North Carolina Room related to Transylvania County families, businesses, organizations and history. Please join us for Marcy's presentation on a fascinating period of local women's history.

CRITICAL AAUW VOTES COMING UP

All members should have received notice that AAUW National has put three bylaws amendments before the membership for a vote this spring. These amendments would (1) create three-year staggered terms for national board members, (2) allow non-members to serve on the national board, and (3)



eliminate the degree requirement for membership.

Bylaws amendments are not traditionally proposed outside national convention years, but these changes have been under consideration for several years.

At its annual meeting on March 24, AAUW NC approved a resolution that "...branches and members become familiar with the three proposed amendments and support their passage by voting in the affirmative prior to June 9, 2018."

National Dues Increase

Membership renewal forms will go out in early April, and members will notice an increase in dues. Effective March 16, national dues increased from \$49 to \$59 per year, the first change in nearly a decade. As a result, total dues for annual membership will be \$80 (national \$59 + state \$11 + branch \$10). Of this amount, \$56 will be tax deductible.

Annual dues currently account for about 13 percent of AAUW National's yearly budget. The remainder is comprised of donations and corporate and foundation funding. We hope you will find the work that AAUW national does worthy of this increase.



AAUW LEGAL ADVOCACY FUND

In National Institute of Family and Life Advocates (NIFLA) v. Becerra, the Supreme Court will decide whether the notices that a California law requires crisis pregnancy centers to post violate the First Amendment.

AAUW signed on to an *amicus* brief that addresses the deception and harm produced by crisis pregnancy centers which may refuse to disseminate accurate information about reproductive options. Denying women the full range of family planning and pregnancy-related medical services undercuts women's rights and has far-reaching consequences that could jeopardize their economic security and access to education.

NIFLA challenged a California law that requires licensed pregnancy centers to post or hand out information about the availability of low-cost or free family planning services, prenatal care, and abortion services as well as a phone number to contact to determine eligibility. This law also requires unlicensed facilities to post or hand out information that makes it clear that they are not licensed and do not have a licensed medical provider. The U.S. District Court rejected its argument, as did the U.S. Court of Appeals. The case was heard by the Supreme Court on March 20; a decision is expected by the end of June.
